The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On November 13, 2019, Deputy B. Shannon made contact with the defendant in the driver seat of her black 2019 Porsche Cayenne bearing Florida license plate#:0774QT (VIN: WP1AA2AYXKDA09879) in the rear parking lot of the closed China Pearl Buffet located at 8935 Dale Mabry Hw. N. The vehicle was running, not in a parking spot, and the front wheels were off of the parking pad in the dirt facing a wooded area. Deputy Shannon observed the defendant to have bloodshot and watery eyes, slurred speech, to have difficulty locating her driver license after passing it multiple times, and detected the odor of an alcoholic beverage emanating from her breath. I made contact with the defendant and observed her to have bloodshot and watery eyes and I detected the strong odor of an alcoholic beverage emanating from her breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. Once at Central Breath Testing, after being advised of the Implied Consent Warning, the defendant refused to provide lawful breath samples. I confirmed the defendant's identity via DAVID.
