The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/14/2021 at approximately 2228 hours, while searching for a reckless driver seen by a concerned citizen, Deputy Gill #259139, observed the defendant's vehicle (matching the reckless driver's vehicle description) approximately one mile down on Palm River Rd from 50th St, was the black Volkswagen Passat (Washington tag # AMM7880) parked on the side of the road, and on the sidewalk, with the vehicle lights off. The defendant was observed parked on the side of the roadway, with the defendant still in the drivers seat, by Deputy Gill. Deputy Gill made contact with the defendant and noted several indicators of impairment such as bloodshot watery eyes, the strong odor of an alcoholic beverage emitting from her breath and slurred speech. Upon my contact with the defendant, I observed several indicators of impairment. During the completion of the SFSE's, I observed several more indicators displayed by the defendant. Once at CBT, the defendant refused to provide the lawfully requested breath samples, after being read implied consent in CB-01. I issued the defendant DUI citation 5133XGA for DUI (refusal). The defendant identified herself via Washington DL.
