Probable Cause Affidavit

Before me this date personally appeared MURPHY, JESSICA (PD1066) who being first duly sworn deposes and says that on 7 day of May, (year) 2017 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

CHEST. [REDACTED] ADVISED THEY HAD A VERBAL ALTERCATION AND [REDACTED] WANTED HER TO SLEEP IN ANOTHER ROOM. [REDACTED] ADVISED [REDACTED] TRIED TO GET INTO THE BEDROOM WITH KNIFES.

THE DEFENDANT (KAROL VILLEGAS) ADVISED SHE CONTACTED THE POLICE AND "IF SHE HAS TO GO TO JAIL THEN FINE". VILLEGAS APPEARED INTOXICATED AND ADVISED SHE DID NOT KNOW WHERE [REDACTED] SCRATCHES CAME FROM AND THAT THEY HAD A VERBAL ALTERCATION BECAUSE SHE [REDACTED] BUT "THEY ALWAYS SLEEP IN THE SAME BED AND WANTED TO GET INTO THE ROOM SO SHE USED THE KNIFES TO HIT THE DOOR".

[REDACTED] WAS PRESENT DURING THE ALTERCATION AND ADVISED "I DON'T KNOW WHAT HAPPEN TO HER BUT SHE WENT CRAZY". [REDACTED] SHOWED MYSELF AND OFFICERS ON SCENE A VIDEO RECORDING OF THE ALTERCATION. IN THE VIDEO IT APPEARS [REDACTED] WAS REFUSING TO LET VILLEGAS IN THE BEDROOM SO SHE GRABS [REDACTED] BY [REDACTED] HAIR AND BRINGS [REDACTED] HEAD DOWN TO HER FACE. VILLEGAS THEN GOES INTO THE KITCHEN AND GRABS KNIVES AND PROCEEDS TO STAB THE DOOR NUMEROUS TIMES WHILE [REDACTED] IS STANDING WITHIN 2 FEET. [REDACTED] ATTEMPTS TO DISARM VILLEGAS NUMEROUS TIMES. [REDACTED] ADVISES [REDACTED] "TO CALL THE POLICE, JUST CALL THE POLICE".

[REDACTED] REFUSED TO GIVE A SWORN STATEMENT AND WAS VERY UNCOOPERATIVE. [REDACTED] ADVISED [REDACTED] DID NOT WISH TO PRESS CHARGES HOWEVER THE INVESTIGATION DETERMINED VILLEGAS TO BE THE PRIMARY AGGRESSOR.

VILLEGAS WAS DETAINED AND TRANSPORTED TO CSPD BOOKING THEN LATER TURNED OVER TO BSO CUSTODY.
