The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was stopped for speeding (paced 55 MPH in a 45 MPH zone), weaving in her lane of travel, and tailgating. The defendant was driving her 2019 Ford Edge, bearing FL tag #IBEA99. Upon making contact with the defendant, she displayed multiple indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on her breath, bloodshot/glassy eyes, admission to consuming alcoholic beverages, conflicting statements about where she was coming from, and uncoordinated reflexes while looking for her documents. The defendant performed poorly on the SFSEs, and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC .109/.108.

HCSO Deputy A. Santos (ABN 149560) searched the defendant's purse upon arrival at the Hillsborough County Jail, and located a small jewel baggie containing a white powdery substance. The substance had the appearance of powder cocaine, and field tested positive for cocaine.

The defendant identified herself via her FL driver's license.
