The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 07/13/2021, at approximately 0105 hours, at the intersection of Lumsden Rd W and Woodview Dr, Deputy Castelli (ABN 259811) contacted the defendant on a traffic stop for driving on the wrong side of the roadway. The defendant was traveling east on Lumsden Rd in the west bound lanes. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI and transported to Central Breath Testing where the defendant stated she would provide a breath sample. During the 20 minute observation period, the defendant changed her mind and stated she no longer wanted to provide a breath sample. I advised the defendant of the Implied Consent warning in CB-01 room in CBT, where she still refused (see video). Subsequently, I completed the Affidavit Of Refusal To Submit To Breath Test. The defendant was positively identified via a Florida DL photograph.
