The defendant was driving a gray 2016 Ford F-150 bearing a Florida license plate of Z25AJI. She was traveling east on Adamo Dr between 50th St and Orient Rd and was traveling at a high rate of speed. Your affiant made a u-turn and caught up the the listed vehicle and at this time the vehicle braked and slowed down. However, the vehicle then slowly sped up and was paced traveling 68 MPH in a 50 MPH zone. In addition, the vehicle was weaving back and forth, and actually crossed over the lane dividers several times. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, fumbling fingers, and an admission to consuming alcohol (one beer). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .176 and .163.

The defendant was identified by her FL DL.
