The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 02/25/2020, at approximately 0655 hours, at 1903 Havenview Ln., Lutz, FL, 33558 the arrestee, who verbally identified herself as Katelynn Malterer, battered the victim against his will. The arrestee is the ex-wife of the victim. They share two children in common, and they currently live together as a family. The arrestee and the victim got into a verbal argument. Soon after, when they were inside the master bathroom, the victim reached over to grab a hair comb. The arrestee then used her hands to push the victim against his upper body. The victim pushed the arrestee back in self defense in order to get the arrestee away from him. The arrestee then picked up a glass q-tip container and struck the victim over the head with it. As a result, the victim suffered a laceration on the left side of his head, and several streams of blood poured down his face. Immediately after being struck over the head with the solid glass container, the victim pushed the arrestee away from him again. The victim used his hands and pushed the victim away, on the victim's upper body, on her neck. The arrestee was determined to be the primary aggressor. There were two young children inside the home when this occurred, however neither of them saw the physical altercation. The only heard the physical altercation, from a different room. The victim positively identified Katelynn Malterer as the person who committed this crime. Katelynn Malterer was positively identified via HCSO RMS arrest photo #863696.
