The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On the above listed date and time, at the above listed location, Deputy Kraus #254717, arrived to conduct a crash investigation (see HCSO 20- 435271; DHSMV #89426910). Deputy Kraus observed a white Toyota Prius bearing Florida tag: KPKZ22, crashed into a tree. Deputy Kraus advised me the damage was approximately \$10.000 dollars. Upon making contact with the driver/defendant, Deputy Kraus observed signs of impairment. I responded to the scene, detected the defendant to have glassy and bloodshot eyes and a distinct odor of an alcoholic beverage emanating from her breath. I requested the defendant perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. Due to her level of intoxication, the defendant was unable to perform the exercises. Based on the totality of the circumstances, the defendant was placed under arrest for DUI. Upon arrival at the Central Breath Testing CBT, the defendant agreed to provide two lawful samples to determine her breath alcohol content (BrAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of her breath which resulted in a BrAC of .350/.348. The defendant was identified via her Florida Driver's License
