The defendant was driving her 2009 Kia 4-door, bearing OH tag #HXW1275. Upon making contact with the defendant, she displayed multiple signs of impairment, including: slurred speech, a strong odor of an alcoholic beverage on her breath, a club admissions wristband on her right wrist, an admission to consuming alcoholic beverages, sluggish responses, difficulty dividing her attention, unsteady on her feet, and swaying as she stood. The defendant exhibited several clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .161/.151. The defendant identified herself via her OH driver's license.
