On the **17th** day of **July** 20**20** at **2315** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On 07/17/2020, at approximately 2300 hours, I responded to [REDACTED] in the incorporated [REDACTED] Palm Beach County, Florida [REDACTED] in reference to a domestic disturbance in progress between the complainant, later identified as Vivian Sanchez and her mother in law, later identified as Katherine Gomez.


Upon arrival, I made contact with the complainant, Vivian outside the complex, who was upset and stated her mother in law slapped her in the face. Vivian advised she had moved to Katherine's residence for approximately six months. Vivian advised while she was watching television in the living room, and Katherine became upset with her because she was not cooking for her son, who was at work. At that moment, Vivian stated Katherine became aggressive towards her in which a verbal altercation started between Vivian and Katherine. As the verbal altercation continued, Katherine took Vivian's cellphone claiming that she wanted back because Katherine was the one paying the bills. Vivian advised she asked for her cellphone back several times, but Katherine refused to return the cellphone at first. Vivian advised Katherine was pacing around with her cellphone, and as she followed Katherine to retrieve her cellphone. Vivian advised she called Katherine a "Bitch" in which Katherine maliciously punched her in the face resulting in them briefly engaging in a physical altercation. During the physical altercation, Katherine continued to attack her, and she had to defend her cellphone. Vivian advised Katherine's husband separated them apart and grabbed her cellphone from Katherine, and returned to her. Vivian provided a written sworn statement accounting for the incident. Vivian was upset and advised she wanted to prosecute. Vivian advised her husband did not witness the fight because he was at work. As I was speaking with Katherine, I could hear Katherine yelling and screaming outside the residence while her husband was trying to calm her down.

After speaking with Vivian, I proceeded to make contact with Katherine who was agitated and extremely upset with Vivian. Vivian advised Katherine is extremely disrespectful, and today she refused to cook for her son. Vivian stated she got upset with Vivian and initiated a verbal altercation with her. Subsequently, confessing that she and Vivian were involved in a physical altercation, but Vivian had hit her first. Katherine advised she had a surveillance video that captured the physical altercation and voluntarily provided a copy to me.

After reviewing the surveillance, I observed Vivian and Katherine engaged in a verbal altercation, and when Vivian followed Katherine to retrieve her cellphone. Katherine went off from the surveillance view, but Vivian remained in the view of the surveillance as Vivian approached Katherine. I observed Vivian's head abruptly moving backward in a motion of being struck in the face, indicating that Katherine had struck her in the face. Subsequently, the physical altercation continued for a few seconds before Katherine's husband separated the fight. In the surveillance video, there was no indication that Vivian had struck Katherine first.

I then made contact back with Katherine and explained the outcome of my investigation in which Katherine started yelling and screaming while stating Vivian was disrespectful towards her. Katherine kept yelling Vivian had hit her first but later confessed that she hit Vivian first because Vivian was extremely disrespectful.

PROBABLE CAUSE STATEMENT

Based on my investigation, Katherine and Vivian's written sworn, surveillance video, Katherine's confession. I conclude that Katherine was the primary aggressor who violated Florida State Statute 784.03 (1)(a)(2) Simple/ Intentional harm battery domestic against Vivian. Katherine was placed under arrest at 2315 Hours.

Katherine was transported to the District for paperwork. Subsequently to the Palm Beach County Jail for booking.

During my interaction with Katherine and Vivian, I did not observe any injuries on them.

A Domestic Violence Probable Cause Supplement, Victim Notification Form, and a Case Information Sheet were all completed. Katherine was also provided a copy of the Victim's Rights Brochure that was explained to her, and she signed for.


I contacted the PBSO hot line Level II domestic violence via the portal page in regards of the incident.

I completed a Domestic Log entry, and I also requested a copy of the 911 recording to be uploaded into STAC.

This case is clear by an arrest.
