The defendant was operating a black 2018 Cadillac XTS, 4 door, Florida tag CITT30. The defendant was stopped for driving at night without head lights on, and she drove in a manner in which the vehicle drifted in the travel lane and crossed onto painted lane divider lines several times. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's speech was somewhat slurred, and her face was flushed. The defendant initially seemed confused and aloof. The defendant was forgetful as related to requested documents, and dropped her driver license between the seat and center console. The defendant stated that she did drink several alcoholic beverages tonight, starting at 1900 hours with dinner. The defendant swayed slightly while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment. Based on a totality of the circumstances, the defendant was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purpose of determining its alcohol content after she was advised of the Implied Consent Warnings. The defendant was positively identified by her FL DL.
