The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a 2013 white BMW two door bearing a Nebraska license plate of WBJ002. She was traveling north on Bayshore Blvd at a high rate of speed and caused a traffic crash when she lost control of her vehicle around S Newport Ave and struck the center cement median and then left the roadway, flipping the vehicle and striking a brick wall. The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, and an admission to consuming alcohol (two vodka drinks). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .122 and .123. The defendant was identified by her FL DL.
