On Wednesday, March 16, 2022, at 20:13hrs, I, DUI Investigator Cameron Carver, was dispatched to Rocco's Tacos, located at 5090 PGA Boulevard, in the City of Palm Beach Gardens, within Palm Beach County, Florida in reference to a suspicious incident. My department issued body worn camera and in-car dash camera was utilized in this investigation and subsequently uploaded to Evidence.com. Palm Beach Gardens Police Dispatch advised the caller reported a white SUV was chasing him. The complainant stated the vehicle was tailgating them and the female driver tried to hit his car with her vehicle. The complainant drove around her trying to avoid her and went to the Rocco's Tacos parking lot and the vehicle followed them into the parking lot.						
On calling the complainant, Christian Campos, he provided a sworn-oral statement advising he was coming from Alton and was traveling southbound on Central Boulevard when a white SUV approached him aggressively and nearly rear-ended him. Campos stated there was plenty of room for the vehicle to go around him and pass him, and they did not. The vehicle continued to tailgate and then eventually went around Campos' vehicle. Campos stated he stopped next to the vehicle at Central Boulevard and PGA Boulevard, at the red light. When the light changed to green, he continued and the vehicle followed him, cut him off, and then accelerated and slowed down in front him. Campos stated he was afraid for his life and tried to avoid her, but the driver continued to accelerate and decelerate and harass Campos. Campos turned into Rocco's Tacos parking lot from Shady Lakes Drive and drove around the parking lot, with the vehicle following him. Campos stated he motioned the female driver to move along, with her continuing to harass him. Campos stated he stayed on scene until law enforcement arrived and at no time did the female driver exit the vehicle or another person take custody of the vehicle.						
Upon arrival, Officer Garito #500 and Officer Medina #527 were at the rear of a white Subaru SUV bearing Florida tag GFUK60, talking with a white female, much later identified via her Florida Driver's License as Kathryn Prince, who was argumentative

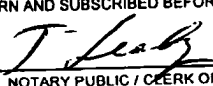
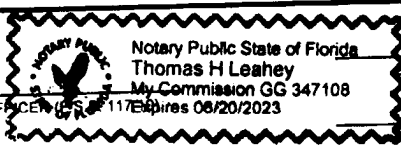

with them. Officer Garito was trying to understand the reason for the complaint by Campos and Prince's involvement, with Prince refusing to answer questions and being belligerent. Officer Medina began to brief me at the rear of his vehicle when I overheard Prince talking loudly about having her attorney present. Officer Medina later told me upon his approach to the vehicle, Prince was still in the driver's seat and the vehicle was still on. Officer Garito attempted to calm Prince down and gather information and Prince asked if she was under arrest. Prince was advised she was not and began to walk away as it was being explained she was being detained for the investigation. Prince attempted to get into her vehicle, which Officer Medina secured, and Prince became upset and argued with him on why she was not allowed to get into her vehicle and why he was ensuring the door stayed closed. Prince would talk over officers and would not answer questions. Prince had the strong odor of an unknown alcoholic beverage coming from her breath as she was talking, which Officers Medina, Garito, and I noted. I also saw her eyes were glassy. Prince stated she did not feel safe with the police and wanted to leave. I informed Prince that I was there to conduct a DUI investigation and she was not free to leave. I asked for Prince's name, and she stated, "I don't have one." I asked for her identification, and she stated she didn't have one either. Prince carried on with this and obstructed the investigation by withholding her identity. Sergeant LeBlanc #363 had arrived on scene, and Officer Medina and I briefed him on the investigation thus far, and he went to speak with Prince. Prince was belligerent with Sergeant LeBlanc, talking over him, making demands, and continuing to not identify herself. Sergeant LeBlanc noted the strong odor of alcohol coming from her breath too and informed her I was conducting an investigation and asked if she was going to cooperate in this investigation. Prince, directly answered, she was not going to participate. Based on her belligerent state, attempting to leave the scene and overall uncooperative nature, I decided to place Prince in handcuffs which were checked for proper fit and double locked, which she attempted to pull and walk away. Based on the totality of the circumstances stated above, I placed Prince under arrest for DUI and Resist without Violence/Obstruction. Prince was informed why she was being placed under arrest. Prince was searched incident to arrest by Officer Garito and her property was taken with her to the Palm Beach County Sheriff's Office. An inventory was conducted on Prince's vehicle, locating two receipts from 03/16/22 with alcohol purchases. First was from 4:24pm, for (1) Heineken "22z" and the second from 5:40pm for (1) Heineken. In the vehicle I found one Heineken 16oz can in a brown paper bag on the passenger floorboard. Additionally, in the driver's door cupholder, there was a cup that had the strong odor of an unknown alcoholic beverage and residual liquor. The receipts and can were seized and turned into the department's evidence section. Prince was transported to the Palm Beach County Breath Alcohol Testing Center (BAT) where she continued to be belligerent, criticize, demand her attorney, and know what her

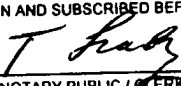

charges are. Upon arrival at the BAT, Prince was placed in a seat and was observed for 20 minutes and did not ingest anything or vomit. While at the BAT, Prince was rude to other arresting officers and me, demanding her phone call and attorney. Prince was uncooperative with obtaining her directory information, ignoring me and being difficult with BAT staff. At the end of the observation, I brought Prince on camera, with Palm Beach County Sheriff's Office Breathalyzer Technician Pound ID#24639 present. Prince again would not provide her directory information on camera, and I requested Prince to submit to the breath test where she refused. Prince began to argue with me, claiming the arrest is baseless and repeating the same questions previously answered. I attempted to read Prince the Implied Consent, but she spoke over me. I read it to her again, which she was silent for, but then stated she did not understand. I informed her the Implied Consent in layman's terms, which she again stated she did not understand because she was distracted by my "big ears." I marked her refusal to submit the breath test at 22:08hrs. Prince was read Miranda Warnings from a pre-printed document and while I was reading it, she would talk over me. Due to her previous requests for an attorney, no questions were asked. At the end of completing my paperwork, Prince refused to sign for her charging affidavit and her three citations. Prince was taken to intake where she continued with her arrogant and belligerent behavior until turned over to the Palm Beach County Sheriff's Deputies. Based on the totality of circumstances from my investigation, I find Kathryn Ann Prince was in actual physical control of a vehicle on the streets of Palm Beach Gardens, while under the influence, and was affected to the extent that her normal faculties were impaired, in violation of Florida State Statute 316.193(1)(A) [AECRJRE]. I also find probable cause to charge Prince with Obstruction/Resist Without Violence, in violation of Florida State Statute 843.02 and Refusal to Sign Citation in violation of Florida State Statute 318.14(3) [AECRJSE, AECRJTE and AECRJWE]. Prince was also issued a citation for Driver in Possession of an Open Container while Parked, in violation of Florida State Statute 316.1936(2)(B) [AECRJUE].
