The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/26/2021 at 1929 hours I responded to the Whiting St E and Morgan St N to assist Tampa Police Officer Brooke Pellegrine(72327) with a DUI investigation. Upon my arrival Officer Brooke was placing the defendant under arrest for DUI based upon all her observations and those of Tampa Detective John Barnett(46033). Detective Barnett conducted a traffic on a blue Ford F-150 pick up truck after he observed the vehicle fail to yield/stop as it left the Foot Brook parking garage. Upon contact with the driver/defendant Kathryn Lautner detective Barnett observed signs of impairment. Suspecting that the defendant was impaired Detective Barnett requested a patrol unit to assist him. At which time Officer Pellegrine responded to the scene. Upon her arrival Officer Pellegrine made contact with the defendant and observed that she had blood shot eyes and slurred speech. Officer Pellegrine then asked the defendant if she would be willing to perform the standardized field sobriety exercises and the defendant refused. At which time Officer Pellegrine placed the defendant under arrest for DUI based upon on all of her observations. The time of arrest was 1913 hours. Officer Pellegrine then transported the defendant to the HCSO/CBT Facility where she refused to provide a breath sample. Implied Consent was read at 1942 hours. The defendant was identified with a FL DL.
