The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On March 7, 2021 the defendant was operating her black 2011 Mazda3 bearing Florida license plate#: 1Q09WY (VIN: JM1BL1UF2B1394148) Eastbound on Bearss Av. W, the defendant failed to observe a gray 2020 Nissan Altima bearing Florida license plate#: 1IJJ61 (VIN: 1N4BL4CVXLC273857), operated by victim Tyler Russo, in front of her. The front of the defendant's vehicle struck the rear of the victim's vehicle causing approximately \$4000.00 in damages. The victim positively identified the defendant as the driver of the vehicle. Deputy J. Spear ABN#: 245769 observed the defendant in the driver's seat of her vehicle upon his arrival. Upon contact, Deputy Spear observed the defendant to have bloodshot watery eyes, slurred speech, and he detected the odor of an alcoholic beverage emanating from her breath. I made contact with the defendant and observed her to have bloodshot watery eyes, slurred speech, and I detected the odor of an alcoholic beverage emanating from her breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. Post-Miranda the defendant admitted to consuming two Keystone Light beers and a shot of vodka. Once at Central Breath Testing, after being advised of the Implied Consent Warning, and after a twenty-minute observation period, the defendant provided lawful breath samples showing a breath alcohol concentration of .227/.227. I confirmed the defendant's identity via DAVID.
