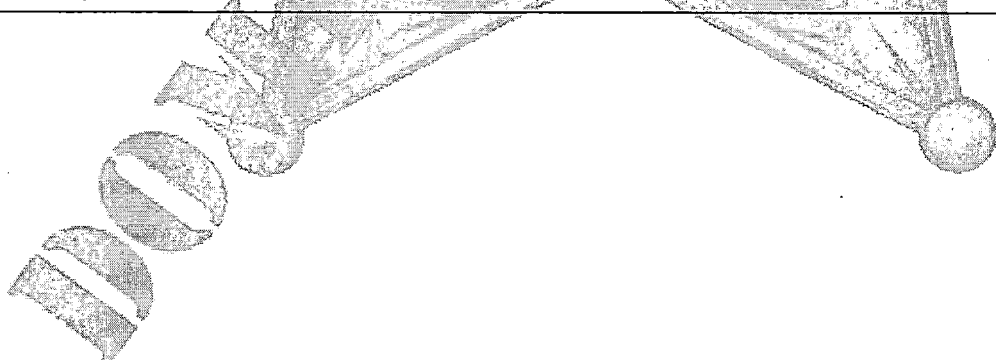

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 05/25/2020, at approximately 1252 hours, at 6124 Gannetwood Pl. The defendant and victim were involved in a verbal altercation which turned physical when the defendant unlawfully threw a diffuser at the victim, pulled on the victim's beard, slapped the victim on the left side of the face with an open hand, and threw coffee creamer on the victim's shirt against his will.
