The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 09/27/2020, at approximately 0239 hours, at the intersection of Bloomingdale Av and Duncan Rd, Deputy Gibb #257675 contacted the defendant on a well fare check to see if the defendant was ill/sick tired or impaired based on the defendant's driving pattern. Deputy Gibb also observed an open beer bottle in the center console that was half full. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. Post Miranda the defendant admitted to drinking two white claw seltzers. Based on the totality of the investigation, the defendant was arrested for DUI and provided two lawful breath samples of .198 and .198 BAC. The defendant was positively identified via a Florida DL photograph.
