The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 01/27/2021, at approximately 0014 hours, the affiant was traveling southbound on 301 Hw S, when the affiant observed a white Volkswagon Passat, bearing Florida Tag KTCJ (VIN:3VWLP7AJ9CM384822), to be traveling in front of his patrol vehicle. The affiant observed the vehicle drifting within its lane, the left turn indicator to be activated without turning left, and following to close the the vehicle in front it. The affiant conducted a traffic stop on the vehicle to check on the well being of the driver to see whether they were ill, tired, or impaired. Upon contact with the defendant, the affiant detected to the distinct odor of an alcoholic beverage emanating from her breath, her speech to be slurred, and her eyes to be red/bloodshot and watery. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which she agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT she refused to provide a lawful breath sample after Implied Consent was read and understood. The defendant was positively identified via her valid Florida driver's license.
