(Specifically include facts constituting cause for arrest.)</p> <p><b>On the above date and time, I responded to 1230 South Lakeside Dr, located in the City of Lake Worth Beach, Palm Beach County, Florida in reference to a violation of a no contact order.</b></p> <p><b>Upon arrival I met with the complainant, Richard Gladstone. Gladstone advised that is currently undergoing the divorce process with his wife, Katrina Chebotar. Gladstone and Chebotar attended a court hearing on Wednesday September 30, 2020 reference court case# 50-2020-DR-007594-XXXX-NB. During the court proceedings, Gladstone was issued Domestic violence injunction for protection against Chebotar, which was read and served to Chebotar in open court, on September 30, 2020. The domestic violence injunction for protection stated that Gladstone would be granted the couples residence and Chebotar was to remain 500' from the residence, however was allowed a onetime visit to the residence accompanied by law enforcement to gather her personal belongings. The domestic violence injunction for protection stated that Chebotar was to have no communication with Gladstone, with the exception that they can communicate through a third party parenting application regarding the care of the child the two have in common. At approximately 1600hrs on Wednesday September 30 2020, prior to the court being dismissed, Chebotar left the court room. At 1610hrs on Wednesday September 30, 2020, Chebotar sent several text messages to Gladstone as she left the court, stating "You win", "I'm leaving and you will never see me again", "Phoenix is your 100%", "Good luck with your life", and "I will pick up Phoenix and bring him home for you all pack my stuff and be out of your life". After leaving the court, Gladstone returned to the residence at approximately 1805hrs. As Gladstone arrived at the residence, he noticed that his vehicle that is being driven by Chebotar was parked in the driveway. As Gladstone approached the residence he found the front door to be locked he entered the residence using his key, finding Chebotar, their child Phoenix, and Chebotar's mother, Nellie Ahearn, in the residence, without the presence of law enforcement. Gladstone noticed that several of the couple's paintings had been removed from the walls. Gladstone began to speak to Chebotar regarding the situation. According to Gladstone, Chebotar made several suicidal statements during the conversation, before leaving the residence with her mother, in the vehicle which she had driven to the residence, leaving her child in the custody of Gladstone.</b></p> <p><b>After Chebotar had left the residence, Gladstone entered his sons room to change his sons diaper. While in the room, Gladstone noticed that an Apple iPad that had been connected to his son's television was gone and all of the diapers had been removed from the room. Gladstone attempted to drive to the store to purchase more diapers, however realized that the only child safety seat that the couple owns was in the vehicle that Chebotar was driving. Gladstone attempted to enter the room in which Chebotar had been using while the couple was separated, which contained the household safe. As Gladstone attempted to enter the room, he noticed that the door along with several nearby doors had been locked by Chebotar, prior to her leaving the residence. Due to the doors being locked and Gladstone not having a key, he was forced to call a locksmith to gain entry to the rooms. After entering the room in which Chebotar had been using, Gladstone found several jointly owned paintings that had been removed from the walls of the residence had been placed on the bed in the room by Chebotar. As Gladstone approached the household safe in the closet, which had contained several thousand dollars worth of jewelry and cash, he found the safe to be empty and left open. At approximately 1933hrs on Wednesday September 30, 2020, Chebotar continued to text Gladstone, however the conversation was initiated by Gladstone.</b></p> <p><b>Based on the above information, I find sufficient evidence that Charge Katrina V Chebotar (11/2/83) did return to 1230 South Lakeside Dr, in the City of Lake Worth Beach, without the presence of law enforcement and contacted Richard J Gladstone (8/30/55) after the injunction for protection against Domestic Violence had been served in open court. Due to her actions, I find probable cause to charge Katrina V Chebotar (11/2/83) with violation of an injunction for protection against Domestic Violence pursuant to FSS 741.31(4)A.</b></p> |   |  |  |  |   |  |  |                 |                                    |
