The defendant was driving her 2002 Toyota 4dr, bearing FL tag #LGHM90. The defendant's passenger was identified by the witness as the driver of the vehicle at the time of the crash. The defendant displayed multiple indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on her breath, unsteady on her feet, stumbling, and bloodshot/glassy eyes. The defendant performed poorly on the SFSE's and she was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .127/.135. The defendant identified herself via her FL driver's license.
