The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a white 2019 Hyundai Tucson SUV (FL TAG #Y18MKV) northbound on Howard Av S, when she ran the steady red light at Cleveland Av W and pulled out in front of me. After pulling in behind the vehicle and running the tag, I observed it to proceed northbound and run the steady red light at Kennedy Bl W. During the traffic stop for the 2 red light infractions, the defendant was identified via a USA Passport, and exhibited several clues of impairment, to include: watery/bloodshot eyes, blank/dazed stare, slurred speech, slow deliberate movements, fumbling fingers, tired/lethargic appearance, admitted to drinking "a tequila and a tequila" while at a bar, and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she provided 2 valid breath samples, measuring .175/.171 BrAC.
