The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On November 6, 2020 at approximately 0143 hours, the driver/defendant was operating a blue Nissan Frontier pick-up truck bearing Florida tag: IL50UP (V.I.N.: 1N6AD0ER2KN759137) when it struck a 2013 white Honda Fit bearing Florida tag: NTEL05 (V.I.N.: JHMGE8G55DC051500) nearly head-on, on 60 Highway East near the intersection with Miller Road North in Valrico, Florida within Hillsborough County causing approximately \$10,000 worth of property damage. The victim of the crash identified the Nissan Frontier by its color, license plate frame, part left at the scene, and a letter on the tag. The Nissan Frontier fled the scene of the traffic crash without providing information to the victim. The crash was investigated under H.C.S.O. case #20-716846 (DHSMV #89440901). As the Nissan Frontier fled the scene of the crash southbound on Miller Road, it crashed into a Frontier Communications Pole at the intersection with Lithia Pinecrest Road, causing approximately \$2,500 worth of property damage. The second crash was investigated under H.C.S.O. case #20-716845 (DHSMV #89440972). Deputy A. Juncal (ABN:253879) heard the crash while on a different call-for-service and located the Nissan Frontier with the driver/defendant seated behind the wheel with the engine on. On contact with the defendant, he detected indicators of impairment to include; she spoke with slurred speech; her eyes were bloodshot and glassy, she was unsteady on her feet when she exited the Frontier, and she leaned against the truck for balance. The affiant responded to the scene and on contact with the defendant, she observed indicators of impairment to include; bloodshot glassy eyes, the distinct odor of an alcoholic beverage emanating from her breath, unsteadiness on her feet, and a sway while standing. The affiant requested the defendant perform Field Sobriety Exercises which she agreed to do. Throughout the performance of the Field Sobriety Exercises, the defendant displayed additional indicators of impairment and was subsequently arrested for Driving Under the Influence with Property Damage and Fleeing the Scene of a Crash without Providing Information. The defendant was transported to Central Breath Testing where after a proper twenty-minute observation period was conducted, she provided two lawful breath samples of .185/.181% B.A.C. respectively. The defendant identified herself via Florida Class E Driver License.
