



I had just exited northbound I-95 on the westbound off ramp. As I merged with West Indiantown Road, I observed a blue Hyundai SUV bearing Florida license plate NSUI37 pass my vehicle at a high rate of speed. This is a posted 50 mile per hour zone. I visually estimated the vehicle's speed at 70 miles per hour. I activated my in car radar (Stalker Dual SL s/n DD005051) in same direction moving mode. I saw the patrol speed matched my vehicle's certified speedometer. I saw the target speed indicated a speed of 72 miles per hour. I heard a clear audio Doppler tone. At the time I confirmed my observation, there were no other vehicles between ours and no other vehicles moving appreciably over the speed limit. I caught up in traffic and stopped the vehicle as it traveled west on West Indiantown Road. I initiated a traffic stop, and the vehicle moved to the right hand turn lane at Marsala Court and stopped abruptly.</p> <p>I walked up to the driver's side of the vehicle and spoke to the driver/sole occupant, identified to me by Florida driver's license as Kayla Garner. I could immediately smell the odor of marijuana coming from within the vehicle. I asked Garner about it and she produced a clear plastic bag containing marijuana. Garner also gave me a glass marijuana smoking pipe. I asked Garner about what else she may have in the car and she gave me her purse, stating there was some marijuana oil in there. I waited for backup. Officer Coleman arrived a short time later and I had Garner exit her vehicle. Garner exited. A search of Garner's vehicle revealed a black marijuana grinder in the center console. There was also a small glass container with a substance I know to be marijuana concentrate. It was listed as "AK-47 Code Red" and was labeled as 1 gram of "420 compliant" "Diamond Sauce." A later check on the internet located a near identical</p>

The initial sample did not react for the presence of THC. A second test reacted positively for the presence of THC, the main psychoactive ingredient in marijuana.</p> <p>At that time I placed Garner under arrest and secured her in handcuffs, which I checked for spacing and double locked. I secured Garner in the rear of my patrol car. A short while later, Garner's father, Phillip Garner arrived on scene. I turned Garner's property and vehicle over to him. I then transported Garner to the Jupiter Police Department for processing. I completed my paperwork and then transported Garner to the Palm Beach County Jail where I transported her to the Palm Beach County Jail where I charged her with the following offenses per Florida State Statute: Possession of Marijuana Oil/Concentrate per FSS 893.13(6)(A), Possession of Marijuana under 20 grams per FSS 893.13(6)(B) and Possession of Drug Paraphernalia per FSS 893.147(1).</p> <p>My issued body worn camera captured my on scene investigation. Garner was very polite and cooperative during my encounter with her.</p>
