Probable Cause

On March 23, 2021 at 3:58 PM I stopped a 2013 GMC Acadia white in color for 81 mph in a posted 45 mph zone northbound on US-27(SR-25) north of the 59 mile marker. Also the vehicle was utilizing the left shoulder to pass other traffic. The vehicle was stopped at approximately the 62 mile marker.

When I approached the vehicle I observed that it was occupied by a female and male. The driver was the female. The female was ID by an Indiana Driver's License as Kayla E. Meyer DOB of 11/20/2001. The passenger was later ID as Christian Hunter Floyd with a DOB of 6/20/1996 by a Indiana Driver's License. While speaking to them at the window I observed a open small cloth storage container with what appeared to be Psilocybin and a bong in it.

Ms. Meyer was asked to exit the vehicle and was asked if there was any CBD or Hemp in the vehicle and she advised no. I advised her of the odor of Marijuana in the vehicle and that I knew the odor. She advised there was some marijuana in the vehicle. The passenger was then asked to exit the vehicle and he advised there was CBD in the vehicle. When told the driver said there was marijuana in the vehicle he advised she didn't know what she was talking about. I asked again if there was marijuana in the vehicle and he advised yes.

When I went to search the vehicle the passenger advised he would get the

marijuana for me but I declined him getting it and started the search. I discovered a dark colored back of labeled cannabis schedule I and a grinder with marijuana in a book bag behind the drivers seat. When I went to the rear of the vehicle the passenger advised there should only be about an 1/8th of marijuana in the vehicle. Upon getting to the cloth storage device on the passenger side floorboard. I again observed the Psilocybin and bongs in the container.

The psilocybin was field tested and tested positive for Psilocybin. The passenger was read miranda and advised the Psilocybin and Marijuana was the drivers property. He advised he knew it was in the vehicle. Ms. Meyer was read miranda and advised the Psilocybin and Marijuana was hers. Ms. Meyer advised she got the Psilocybin in Key West.

The Psilocybin was weighed with the plastic bag it was in at 11.2 grams. The marijuana was weighed at 3.2 grams without the package. The marijuana field tested positive.

Ms. Meyer was arrested and charged with the following charges:
Possession of a controlled substance without a prescription(Psilocybin) in violation of F.S.S. 893.13.6a

Possession of less than 20 grams of marijuana in violation of F.S.S. 893.13.6b

Possession of Drug Paraphernalia in violation of F.S.S. 893.147.1

Ms. Meyer was issued a traffic citation for 81 mph in a posted 45 mph zone and a warning for passing on the shoulder.

Ms. Meyer was booked into the Palm Beach County Jail in Belle Glade.


