The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was in actual physical control of a red 2002 Mazda Miata, 2 door convertible, Florida tag U70XH, and was the sole occupant. The defendant was located by TPD Officer R. Whitlock (52462) stopped at a traffic signal, in a left turn lane, without head lights on, with the engine on. The defendant's left foot was on the vehicle clutch pedal with her right foot on the vehicle brake pedal, and the vehicle gear shift was in drive. The defendant was asleep at the wheel, with her head slumped forward and eyes closed. The defendant had a strong and distinct odor of an alcoholic beverage on her breath. The defendant's face was flushed, and her eyes were bloodshot, glassy, and watery. The defendant's speech was slurred, and her movements were lethargic. The defendant only admitted that she had drank "a little bit" of an alcoholic beverage and would not quantify the amount. The defendant was not forthcoming with information as far as where she had been coming from or how much alcohol she had to drink tonight. The defendant was unsteady exiting the vehicle, her gait was unsteady, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant provided breath samples of .230% BrAC and .212% BrAC. The defendant was positively identified by her Florida DL.
