The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 07/22/2021, at approximately 0211 hours, at the intersection of Bloomingdale Ave and Kings Av, Deputy Castelli (ABN 259811) contacted the defendant on a traffic crash investigation. A wheel witness observed a maroon in color Honda coming south on Kings Av at a high rate of speed then attempted to turn east onto Bloomingdale Ave. The maroon Honda struck an electrical crosswalk sign and damaged the curb. The wheel witness observed the defendant behind the wheel immediately after the crash. The defendant was the sole occupant of the vehicle. Deputy Castelli advised the defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. Deputy Castelli completed the traffic crash investigation and estimated the property damage at approximately \$20,000. I advised the defendant the traffic crash investigation was complete and I was conducting a separate DUI investigation. I read the defendant her "Miranda Warnings" from an agency issued Warning of Constitutional Rights card. The defendant stated "I'm drunk as fuck". Standardized Field Sobriety Exercises were refused. I advised the defendant her refusal could be held against her in a criminal proceeding and I would have to base my investigation on my observations. The defendant still refused. Based on the totality of the investigation, the defendant was arrested for DUI property damage. The defendant refused to provide two lawful breath samples. I advised the defendant of the Implied Consent warning in CB-01 room in CBT, where he/she still refused (see video). The defendant was positively identified via a Florida DAVID photograph.
