The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 1/22/20, at approximately 1900 hours, at 13802 21st St N, Tampa, FL, 33612, after a verbal argument, the defendant unlawfully struck the victim in the left side of the face with a closed fist and spat on the victim against his will. The victim and defendant are husband and wife, were together for ten years, and used to live together as a family but are now separated. The defendant and the victim have two children together. The victim positively identified the defendant as the one who committed the offense.
