The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a gray 2021 Toyota SUV (FL TAG #GUZG11) southbound on Armenia Av N at a high rate of speed and drifting in and out of her lane, over the lane divider lines. I paced behind her vehicle for several city blocks at 60 MPH. This section of Armenia Av N is a posted speed limit of 40 MPH. During the traffic stop for speeding and the suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, slow deliberate movements, poor coordination, appeared lethargic, admitted to drinking alcohol before driving, and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she was read Implied Consent and refused to provide a breath sample.
