The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 09/12/20, at approximately 1510 hours, within Hillsborough County, the defendant and the victim engaged in a verbal argument that turned physical, when the defendant knowingly and intentionally poured hot candle wax on the victim's body. As a reaction the victim pushed and slapped the defendant with an open hand on the face several times. The hot waxed was poured against the victim's will and caused redness and swelling on the victim's eyes. The defendant also sustained minor redness and swelling to the left facial area do the hand strike.
