The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 08/12/2020 at approximately 0222 hours, a lawful traffic stop was conducted on a white BMW 528i bearing FL tag# NVX119 and vin# WBANU53548CT05894 at the intersection of Hillsborough Av W and Rome Av N Tampa, FL 33603. The defendant was seated in the front passenger seat of the listed vehicle. She was holding a pink and white Guess purse in her lap and retrieved her Florida Driver's License from within the purse. A Hillsborough County Sheriff's Office K9 unit responded to the traffic stop to conduct a free air sniff of the vehicle. The K9 unit advised the dog alerted to the presence of illegal substances within in the vehicle. During the search of the vehicle, your affiant located a black digital scale within the pink and white purse the defendant was previously holding. There was a clear, rock like residue on the metal portion of the scale. A field reagent test of the substance on the scale yielded positive results for Methamphetamine. Post Miranda, the defendant admitted to placing the scale in her purse earlier in the day. The defendant was positively identified via her Booking Photograph (CD:837500).
