On the 9 day of April, 2022 at 20:19 (Specifically include facts constituting cause for arrest.) At approximately 18:15 on 04/09/2022, I was dispatched to a possible crash with injuries at 805 Burt Reynolds Park Jupiter Florida, 33477. Upon arrival, I saw a group of people, a single truck and trailer, and a boat not secured to the dock. I then saw the driver, who I later found out to be the offender, Kenneth Allen Sumerfield; W/M; 10/09/1981, sitting on the curb in front of his truck. Officer Schneider was the first officer on the scene, he had Sumerfield park his vehicle bearing FL tag EXXE28, and exit the vehicle. Officer Schneider advised Sumerfield was in the driver's seat and the vehicle was running. See Officer Schneider's supplement report for further. I attempted to get information from Sumerfield by first asking a simple question, his name. Summerfield was in a daze, had a disheveled appearance, and did not answer my questions with a straight answer, his words were slurred and he would not look up at me. I then attempted to ask his passenger, Cheryl A Ruiz; W/F; 01/15/1984, what happened, she advised she would not tell me anything. I then went to speak to the group of people who witnessed Sumerfield's chaotic incident. As I was walking over to the group I saw Sumerfield's boat slanted in the boat ramp and not secured to the dock. I spoke with the caller and witness, Peter Frank Planes; W/M; 03/05/1964, He stated that he believed Sumerfield was intoxicated, he advised when Sumerfield was attempting to get his boat on the trailer the strap broke and it fell off. Planes then stated Sumerfield drove around the parking lot in an unusual manner almost running over his passenger and hitting other vehicles. I then went back to speak to Sumerfield again, he still had a disheveled appearance and I could smell the odor of an unknown alcoholic beverage coming from his breath. I asked him if he had been drinking to which he responded yes he had been drinking beer, I asked how many and he stated he had a couple. I requested that Sumerfield perform standardized field sobriety tasks so I know he could safely drive home. He stated he

I utilized my body worn camera during the below incident: On Saturday, 04/09/2022, at approximately 1815 hours, I was enroute to Burt Reynolds Park East located at 805 N US Highway 1, Jupiter, FL 33477 in reference to a possible crash with injuries. While I was enroute in Jupiter Police patrol vehicle #1610, I had my emergency lights and sirens initiated. Upon entering the park, I turned my sirens off but my emergency lights were still on. I was immediately being flagged down by several patrons inside the park, and they were all pointing in the direction of a large white pickup truck parked in front of the boat ramp. The truck was white 2000 Ford F-350 bearing FL tag EXXE28. While I was still in my patrol vehicle, I could see a white male in the driver seat of the truck and it was running, I could also see a white female standing outside the open front passenger door. The two individuals appeared to be in heated verbal argument. I parked my vehicle and exited wearing my issued Jupiter Police uniform and made contact with the driver. During my approach, the patrons were advising the male appeared to be intoxicated and I could hear the female was screaming at the male to get out of the truck. I made contact with driver later identified as Kenneth A Sumerfield (wm; 10/09/1981). Sumerfield did not appear to have any injuries while he was sitting in the truck and did not complain of any as well. I noticed that Sumerfield was showing signs of intoxication during my brief contact. His face was flushed and disheveled and his eyes were glassy and bloodshot. I told Sumerfield to turn the truck off and to step out. After several attempts, Sumerfield finally complied. When Sumerfield stepped out of the truck, he was unsteady on his feet and I could smell the odor of an unknown alcoholic beverage coming from his person. I did not see any injuries to Sumerfield while he was standing outside the truck either. I patted Sumerfield down for weapons and at the conclusion I advised to go sit on the nearest curb. Sumerfield was also unsteady

	on his feet while walking to the curb. At this point and time, Officer Picard #356 arrived and remained with Sumerfield while I made contact with the female. The female was later identified as Cheryl A Ruiz (wf; 01/15/1984) who advised that Sumerfield and she were just in a verbal argument over their boat falling off the trailer. Ruiz did not have any visible injuries and also did not complain of any. I later made contact with Officer Picard and advised her of my observations of Sumerfield while he was in the running truck, as well as outside of the truck. Officer Picard proceeded to conduct a DUI investigation, where she later found probable cause to arrest him for suspicion of DUI. This concludes my involvement with the above case.

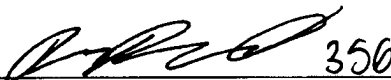

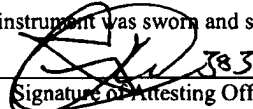
