The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: I observed the defendant driving a white BMW with FL tag NCQD29 on the roadway. He made a wide left turn onto N. Dale Mabry Highway and straddled over the lane line. He accelerated at a high rate of speed and then made a left turn onto W. Spruce Street at a red light. I activated my emergency lights to conduct a traffic stop. I made contact with the defendant who was in the driver's seat. Upon contact I could smell the odor of alcoholic beverages from his breath. His eyes were glassy and bloodshot. His speech was low and slurred. He said he was a risk and drank 2 beers and 2 shots of tequila. He performed field sobriety exercises and showed impairment. Post arrest I advised him of implied consent and he understood and refused a breath test. Defendant ID'd by FL DL.
