On 19 March 2022, I was dispatched to B Concourse Gate 5 Southwest Airlines in reference to an unruly passenger refusing to leave the airplane. Upon arrival, myself and Sgt. Melloy, D/S Shackleford entered the airplane and immediately heard the subject being loud and disruptive in the back, seated in seat 22C. Upon approaching the subject he was advised that he was being refused to fly due to his intoxicated behavior and he agreed and got up. As he was walking through the aisle he was unsteady on his feet and he began arguing with the passengers as he walked by. Fearing and escalation to his actions, he was grabbed and escorted off the plane. The subject was intoxicated to a state that he was unable to walk without falling and he was placed in a wheelchair, and pushed out of the concourse. The subject continued to be loud and profane to all the deputies present while he was being processed. The subject was charged under the provisions of FL State Statute 856.011 (1), Disorderly Intoxication. After processing the subject was transported to the Palm Beach County Jail.
