The defendant was operating a gray 2020 Toyota Corolla, 4 door, Florida tag Y83WHY. The defendant drove in a manner in which the vehicle was weaving in the travel lane, crossed over an into a painted safety zone, and the left side tires drove onto an remained on the center solid yellow painted lane divider. A traffic stop was initiated to check on the well being of the driver to determine if he were sick, tired, distracted, or impaired. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant was evasive as to where he had come from, and stated that he drank three alcoholic beverages today. The defendant agreed to submit to Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant provided breath samples of .035% and .032% BrAC. Urine pending. The defendant was positively identified by his Florida DL.
