The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did  
 On 03/04/2021, at approximately 1722 hours, at the intersection of Memorial Hwy and Anchor Plaza Pkwy, Deputy J. Brizendine (ABN 254009) responded to a traffic crash involving a white Ford F-150 (FL tag:EFMR81) and a green Nissan Murano (FL tag: 342UBP). The defendant was operating the Ford F-150 when he failed to stop at a solid red traffic signal and struck the Nissan Murano. The witness observed the defendant to be the driver of the Ford F-150 at the time of the crash. As a result of the crash, the vehicles sustained approximately \$20,000.00 in damages. The traffic crash was investigated by Deputy G. Melcher (ABN 196293) under HCSO case #21-143766 (DHSMV #89445154). Upon contact with the defendant, he had watery glassy eyes, unsteady balance and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI with Property Damage. Implied consent was read and the defendant refused to provide a lawful sample of his breath. The defendant was positively identified via his Florida driver's license.
