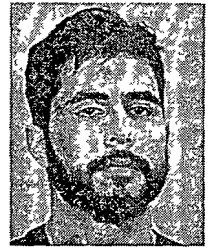

Before me this date personally appeared WILLIAMS DANIEL (3489) who being first duly sworn deposes and says that on 10 day of May, (year) 2017 at [REDACTED] (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

IDENTIFIED THROUGH FCIC/NCIC AS KENNY BARRIENTOS WAS BANGING AT HER HOME'S FRONT DOOR ATTEMPTING TO GET INTO THE RESIDENCE. UPON ARRIVAL AT [REDACTED] RESIDENCE, [REDACTED] OBSERVED THE MALE AND DETAINED HIM UNTIL OFFICERS ARRIVED

PRIOR TO OFFICERS ARRIVAL [REDACTED] STATED TO 911 OPERATORS THAT THE MALE WHO WAS BANGING ON HER FRONT DOOR WAS LEAVING HER RESIDENCE AND SITTING IN A SILVER TOYOTA CAMRY WHICH WAS IN [REDACTED] YARD.

UPON SPEAKING TO KENNY WHO WAS READ MIRANDA RIGHTS FROM A PREPARED TEXT KENNY DID NOT WISH TO TALK TO POLICE AND COULD NOT DISPEL MY FEARS OF WHY HE WAS AT THE RESIDENCE [REDACTED] STATED SHE DID NOT KNOW KENNY AND DID NOT KNOW WHY HE WAS AT HER RESIDENCE IT SHOULD BE NOTED KENNY LIVES AT 9620 NW 13TH STREET IN PEMBROKE PINES FLORIDA.

IT SHOULD BE NOTED UPON SPEAKING TO KENNY I COULD DETECT THE STRONG SMELL OF AN ALCOHOLIC BEVERAGE EMANATING FROM KENNY HE HAD BLOOD SHOT EYES AND WAS SLURRING HIS SPEECH

THE SILVER CAMRY BEARING FLORIDA TAG # BJKR14 WAS OBSERVED BY MYSELF TO BE SITTING IN [REDACTED] FRONT YARD AT [REDACTED] AND A SEARCH INCIDENT TO TOW I FOUND 10.2 GRAMS OF A GREEN LEAFY SUBSTANCE IN A CLEAR PLASTIC BAG CONSISTENT WITH THE STREET LEVEL NARCOTIC CANNABIS SITTING IN THE PASSENGERS FRONT SEAT.
