Victim invokes Marsy's Law. On Sunday, February 27, 2022 at 2223 hours Officer Aguirre and I were dispatched to the Breakers Hotel (1 S. County Road-Palm Beach) in reference to a Domestic Battery that was called in by Officer O'Dea, who was performing duties as a Detail Officer. Upon arrival we met Officer O'Dea who stated that while working the Breakers Detail he was advised by Breakers Security that a W/M, later identified as Kent Swig (DOB 01/20/1961 917-744-9400), had pushed a W/F, later identified as [REDACTED] (DOB [REDACTED]) multiple times and then threw a luggage cart in her direction in an attempt to strike her with it. This incident occurred on the west side of the main building near the main entrance and was captured on Breakers Security cameras. We then spoke with Kent who stated that he was involved in a verbal altercation with [REDACTED] and denied any physical contact. We then viewed Breakers Security camera from the area of this incident. The security video showed Kent attempting to strike [REDACTED] with his right hand. Kent then pushed [REDACTED] backwards while his hands were on her shoulders. Kent is then observed taking a few steps away from [REDACTED] before he turned towards her and threw a hotel luggage cart in her direction that struck her hand and caused her to lose her balance. After viewing the surveillance video Kent was placed under arrest for Domestic Violence Battery (784.03(1)). Kent was placed in handcuffs that were double locked. Kent was also searched for weapons and/or contraband and was then seated in the passenger side rear seat of marked patrol unit #809. Kent was then transported to PBPD without further incident. Officer O'dea remained on scene and spoke with [REDACTED] who invoked her rights under
