The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/15/2021 at approximately 0140 hours, I responded to the Seminole Hard Rock Casino near the east tower located at 5223 Orient Road Tampa, FL. 33610 in regards to a Simple Battery DV. Once on scene, I made contact with the Defendant Kerry L Horne (ID via DAVID) and the Victim (Defendant's husband of three years).

I observed the surveillance video which showed Kerry attempting to take the Victim's cellular phone out of his back pocket. The Victim was observed trying to prevent her from taking his cellular phone out of his pocket. Kerry started grabbing the Victim by his upper shoulders while attempting to get his cellular phone. The Victim grabs Kerry hair while he was trying to prevent her from grabbing him and taking his cellular phone. Kerry struck the Victim on his face while walking through the casino.

The Defendant and Victim are husband and wife for three years who reside in the same household without children in common.

Kerry was placed under arrest for Simple Battery DV and escorted to Orient Road Jail Central booking
