The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 08-04-2020, at approximately 2320 hours, at 11570 Captiva Kay Drive, the defendant grabbed the victim's cell phone out of her hand while she was attempting to contact a family member. The victim is the defendant's mother and they reside together as a family. Post Miranda the defendant admitted to taking the phone and the purse from the victim.
