## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On March 31, 2021 at approximately 23:27 I arrived on scene and spoke with crash Investigator J. Foster ID# 9097. He provided the following. He said that the driver Kevin E. Barclay was driving his silver Ford F-150 and then backed into a parked vehicle that was directly behind him. He said that the wheel witness Anthony D. Fonti was standing outside and observed Barclay driving the vehicle at the time of the accident. Fonti said that Barclay backed into the vehicle and pulled away. He then drove the vehicle clockwise around the parking lot and was met by Fonti and other patrons. Barclay then stopped the vehicle and exited. Fonti stayed on scene until Deputies arrived. Fonti provided a sworn video statement regarding this incident.

## OBSERVATION OF DRIVER:

I observed that Barclay was wearing gray pants and blue shirt. I then spoke with Barclay and explained to him that I was conducting an investigation into DUI. I then read him his Miranda Warnings which he stated he understood. While questioning Barclay I observed his eyes appeared red and glassy. I observed that he was slurring his words and his speech was slow. I could smell an odor of an unknown alcoholic beverage emitting from his person that would grow stronger as he would speak. Barclay was asked to perform field sobriety tasks and he agreed.

## DRIVER'S STATEMENTS:

I asked Barclay if he had been drinking or used any drugs to which he said he has a medical marijuana card and he took an edible earlier and while at the Anchor Inn, he consumed three doubles of Southern Comfort. I asked Barclay what medical problems and/or previous injuries they had to which he said none. Barclay said that he takes blood pressure medications and diet pills. He said he does not wear glasses or contacts.

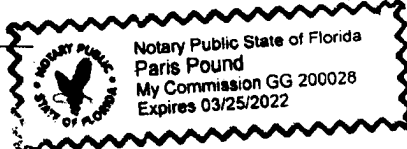

**Other Observations:**

Once positioned in the front of my vehicle, I continued my investigation. I instructed Barclay to keep his hands by his side, stand with his feet together, and follow a red light stimulus with his eyes not turning his head. I asked him if he understood my instructions. Barclay verbally stated he understood my instructions. Barclay however swayed heavily while standing stationary. I observed both eyes to be red, bloodshot, and glossy. His left and right eye displayed equal pupil size, equal tracking, and a lack of smooth. I observed distinct and sustained nystagmus was present in both his left and right eye at maximum deviation during two separate four second evaluations. The onset of nystagmus was prior to a 45 degree angle in both his left and right eye during two separate four second evaluations. I had to remind Barclay to follow the red light with his eyes.

**WALK & TURN:**

I positioned Barclay on a yellow tape line which was on a smooth and level surface, free of any debris and well lit by the headlights on my vehicle and nearby street lighting. I instructed the driver to place his left foot on the line and his right foot in front of the left touching heel to toe. I instructed him that he was to keep his hands at his side and stay in this position until I instructed him to do otherwise. I instructed him to walk nine heel to toe steps counting out loud, while watching his feet. On the ninth step he was to keep his front foot on the line and use his back foot, in a series of small steps, to turn around before walking nine heel to toe steps the opposite direction counting out loud and watching his feet. I demonstrated the task while I was verbally instructing him in the proper way to complete the task. During the task, I observed the driver swayed while balancing, stops walking to steady self, did not touch heel to toe, stepped off the line. Used arms to maintain balance (+6"), did not turn properly, stumbles, and turns other way than I explained.

**ONE LEG STAND:**

I placed Barclay with his feet together and arms at his side. I demonstrated the task as I verbally instructed him to raise one of his feet approximately six inches off of the ground, point his toe towards my patrol car, look at the raised foot, and count out loud 1001, 1002, 1003 and so on until told to stop. I asked him if he understood the instructions and demonstration I provided. After Barclay stated he understood my instructions, the task was performed. While Barclay stood in the instructional position, I observed he started too soon and swayed while standing stationary. While raising his foot he swayed while balancing, put foot down within 30 seconds, when he reached 1009 he stopped and did not continue with the task as instructed.

**FINGER TO NOSE:**

I instructed Barclay to stand with his feet together, make each hand into a fist keeping, extended his index fingers and to place his palms facing up. He was instructed to lower his arms by his side. I instructed and demonstrated the proper hand and arm position and for him to remain in this position while I demonstrated the rest of the task. I instructed and demonstrated him to tilt his head back approximately 45 degrees and close his eyes while waiting for a verbal command of left or right. On the command of "left" or "right", he would raise the requested hand, touch the tip of his finger to the tip of his nose, then bring his hand immediately back down to his side. During the instruction and demonstration of the task he swayed heavily while standing in the instructional position. I asked him if he understood the instructions I provided and he verbally stated he understood. I instructed him to start the task as explained. During the task, I observed that Barclay's finger did not touch the tip of the nose as instructed. Once his finger was close to his face, he searched around his nose until his finger was close to the tip. He touched the sides and top of the nose first, before sliding this finger over to the tip.

**ROMBERG ALPHABET:**

I verbally inquired if Barclay could recite the entire English alphabet. He stated he was able to recite the English alphabet and I instructed him to place his feet together with his arms at his side and stay in this position until told to do otherwise. I instructed him that upon starting he was to tilt his head back approximately 45 degrees and close his eyes. He would begin to state the alphabet in a slow and methodical manner without singing or rhyming it. I asked him if he understood the instructions and he verbally replied he understood. During the instructions he continued to sway while standing stationary. I instructed Barclay to start the task as explained and recited the alphabet correctly.

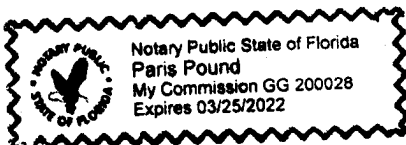

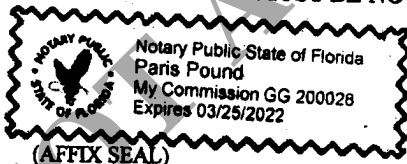

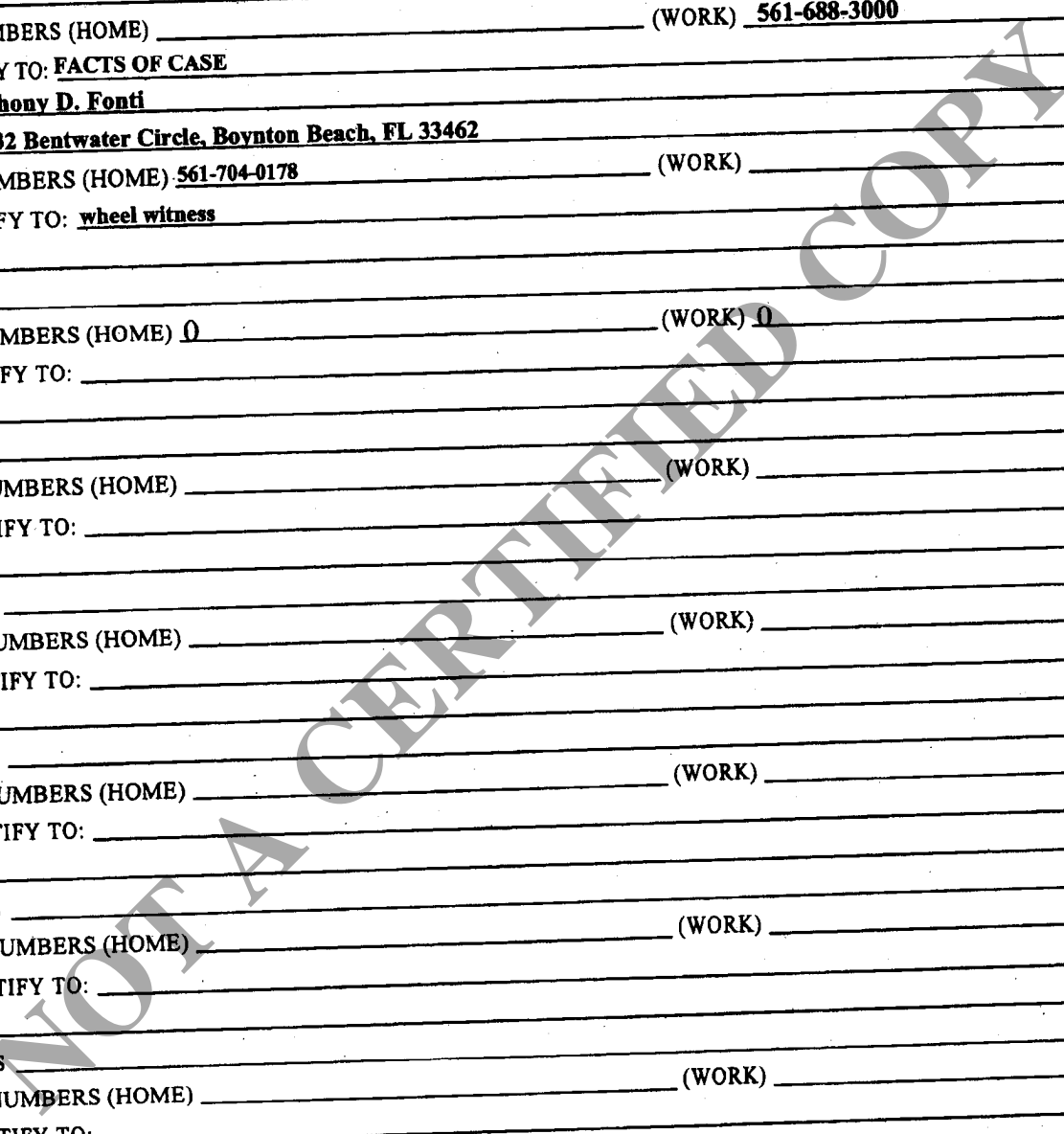
