The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 4/13/2020 at 10039 Tate Ln at a unknown time in the late afternoon the victim, Michelle Gajda was downstairs in her residence with her ex-husband, Kevin D. Kuswa (arrestee) while their two children in common, Hazel Kuswa and Wesley Kuswa were upstairs in the bedrooms. While the victim and arrestee were downstairs a verbal argument ensued between the two of them that turn physical when the arrestee threw the victim into the wall downstairs. When the victim was thrown into the wall by the arrestee she suffer facial trauma that caused two black eyes. The victim confirmed the above information under oath and also confirmed that there is a past history of unreported domestic violence between herself and her ex-husband and on two previous occasions the incidents caused her to go to the hospital for her injuries. The victim refused to complete a sworn written statement, however; the affiant took digital photographs of the victim's injuries to her face/eyes. The affiant provided the victim with a Victim's Rights Pamphlet. The victim positively identified the person who caused the injuries to her face/eyes as her ex-husband and father of her two children. The victim also positively identified the arrestee via his DHSMV photograph. The affiant positively identified the arrestee via Florida Driver License.
