 On 5/25/2020 at approximately 1616hrs, Affiant conducted a vessel stop/safety inspection on a white 23' Hurricane center console deck boat bearing FL3505SP / HIN: GDY55179A020 on the Alafia River at the 301 hw Bridge Riverview, Hillsborough County, FL 33569. Upon stopping the vessel, affiant made contact with the operator/defendant. During personal contact with the defendant, affiant observed the defendant to have blood shot water eyes and slurred speech. Due to this, affiant requested the defendant perform seated sobriety tasks to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance.
