The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 11/03/2019, at approximately 2228 hours, I responded to 12901 Jessup Watch Pl, Riverview, Fl. 33579 to assist Deputy Montrose(ABN:214133) with a suspicious vehicle call for service. The vehicle had been parking in the back of the town house community and leaving liquor bottles and cigarette wrappers everyday for approximately a month. When Deputy Montrose made contact with the defendant, who was in the driver's seat, he smelled the odor of marijuana emitting from the vehicle and observed indicators of impairment coming from the defendant. When I made contact with the defendant, I observed indicators of impairment. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. Post-Miranda, the defendant admitted to smoking marijuana while in physical control of the vehicle. At Central Breath Testing, at Orient Road Jail, the defendant elected to providing a lawful urine sample. The defendant was identified via Florida driver's license.
