The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/9/20, at approximately 2145 hours, Srg Lebovitz advised me that a white Mercedes 4D bearing FI tag LSIY58 (VIN:WDBNG70J9YA036860) drove recklessly to the intersection of Fowler and N 56th St. Affiant observed the vehicle pull into the parking lot located at 12222 N 56th St and stepped out with the defendant. Affiant observed the defendant operating the vehicle and detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. The defendant provided a lawful breath sample that resulted in a BAC of .000/.000. Due to the level of impairment I observed roadside being inconsistent with the breath test results the defendant was requested if he would provide a urine sample and a DRE evaluation in which he stated he would (results pending). The defendant was identified via International DL and passport.
