The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 9/17/2020 at approximately 1137 hours, the defendant was operating a vehicle (SUV), bearing FL tag 18GEC, VIN 1GYS3CKJ8GR160215. The defendant failed to maintain her lane and left the roadway at Gunn Hwy and Lutz Lake Fern Rd struck a wooden power-pole bearing. The witness was driving a pick-up truck and positively identified the defendant as the person that was driving the vehicle bearing FL tag 18GEC, at the time of the traffic crash. I responded to the scene, detected signs of impairment from the defendant, and requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to perform. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant refused to provide a breath sample. The defendant was identified via FL DL. The defendant was given DUI citation A1508WE which reflects the DUI charge.
