The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On the listed date, time and location, I responded to the above listed location in reference to a traffic crash. Upon arrival, I observed a gray in color Chevrolet Trailblazer bearing Florida tag Z28GCX (VIN #1GNDT13S232241912) to be crashed in the ditch on the east side of Kennedy Hills Dr. The defendant was out of the vehicle being checked by Hillsborough County Fire Rescue who was on-scene. I then made contact with the defendant, who was standing by the Chevrolet, and while speaking with the defendant, I noticed she displayed signs of impairment. The defendant was unstable on her two feet and braced herself against the vehicle due to almost falling three separate times. I noted the defendant made several incoherent statements, and her eyes were pinpoint. Based on the observations, Field Sobriety Exercises were conducted, and impairment was observed. The defendant was subsequently arrested for DUI with property damages. Once at Central Breath Testing, the defendant provide a breath sample and blew 000. The defendant also provided a urine sample, which was later impounded into Evidence, and sent to FDLE for testing. The defendant identified herself verbally, and Affiant confirmed her identity by her Florida Driver's License. The property damaged was estimated to be approximately \$21200.
