The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 06/11/2021, at 2126 hours, I conducted a traffic stop at 10121 Horace Av, Tampa, FL 33619. The traffic stop was in reference to a stop bar violation observed by Dep. C. Rideout (ABN 254508). The defendant was the rear right passenger of a gray 2007 Ford F150 bearing FL tag GLCX17.

Dep. S. Ernstes (ABN 235959) and her K9 partner Negen responded to my traffic stop to conduct a free air sniff of the F150 for the odor of illegal narcotics. Dep. S. Ernstes advised me of a positive alert by K9 Negen to the vehicle for the odor of illegal narcotics.

A hand search was conducted and the defendant's belongings were searched. Inside her purse and black wallet she produced her Tennessee Identification Card was an additional Identification Card and Social Security Card belonging to the defendant. I also located one piece of a white-rock like substance inside the wallet. The white-rock like substance tested positive for Cocaine via an issued HCSO Field Reagent Test kit.

The defendant was identified via her Tennessee Identification Card.
