The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 11 day of MARCH, 2020, at approximately 9:17 AM, at 1298 SALT LAKE DRIVE, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE JULITA POGORZELSKI, HER SISTER AND CO-HABITANT, AGAINST THE WILL OF JULITA TO-WIT: THROWING A GLASS CANDLE AT THE VICTIM AND STRIKING HER IN THE HEAD CAUSING A LACERATION TO THE VICTIMS HEAD. THE DEFENDANT MADE A POST MIRANDA STATEMENT AND ADVISED SHE WAS IN A VERBAL ARGUMENT WITH THE VICTIM. DURING THIS ARGUMENT THE DEFENDANT PICKED UP A GLASS CANDLE AND THREW IT AT HER SISTER, STRIKING HER IN THE HEAD. THE VICTIM SUFFERED A LACERATION TO HER HEAD AS A RESULT. THE INJURIES WERE CONSISTENT WITH BEING STRUCK IN SUCH A MANNER.

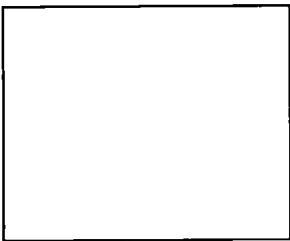
