The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 09/10/2020, at approximately 1225 hours, the defendant was observed seated in the driver seat of his 2019 Chevrolet Silverado bearing Florida tag HWB V07 (Assigned VIN 1GCRWBEHXKZ407029) within the parking lot area of 10033 Gibsonton Drive (Victory Lane Gas Station) by M/Sgt. Bashner (ABN 4573) and Deputy Montrose (ABN 214133) in reference to a person down call for service. Upon making contact with the defendant, M/Sgt. Bashner and Deputy Montrose observed multiple indicators of impairment, to include blooshot/glassy eyes, slurred speech, an inability to stand under his own power, and the distinct odor of an alcoholic beverage emanating from his person. The defendant refused to participate in Standardized Field Sobriety Excersises and was arrested for DUI. Two lawful breath samples were obtained from the arrestee after Implied Consent was read and understood. The defendant/driver admitted to consuming alcoholic beverages this afternoon while declining to participate in Standardized Field Sobriety Excersises. The defendant was positively identified via his Florida Driver's License.
