DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL. On 02/27/21 at 1833hrs a motor vehicle crash occurred in front of 26 SE 9th Ave. A blue Jaguar XJ was stopped in traffic when a silver Honda Accord (FL Tag #PUB881) struck the Jaguar. The front end of the Honda struck the rear end of the Jaguar. After the impact occurred, the Honda reversed and drove away west through an alley. The driver/witness (Officer Patrick Santos) of the Jaguar followed the Honda west on E. Atlantic Ave. Santos was behind the Honda and attempted to stop the Honda by flashing her headlights and honking the horn. While the Honda was stopped at a red traffic signal, Santos called the Jaguar and approached the Honda's driver's door. Santos observed a white male driver sitting in the driver seat and there was nobody else in the Honda. Santos told the white male driver to put out the white male driver waved his hand at Santos and drove away westbound. Officer Patrick Santos observed Santos honking her horn and flashing her lights at the intersection of E. Atlantic Ave. and SE 2nd Ave. Officer Santos met with the white male driver and Santos said that Santos move their vehicle to a nearby parking lot located to the rear of 131 E. Atlantic Ave. I arrived on scene to conduct a DUI investigation. I met with Santos and Santos provided me a sworn statement which was recorded on my body worn camera. Santos stated she did not lose sight of the Honda from the location of the crash to the parking lot where they were stopped. Santos identified the Honda as the vehicle that struck her Jaguar. Santos identified the white male driver in the Honda as the person who was operating the Honda at the time of the crash. Santos stated there was nobody else in the Honda when the crash occurred. Santos stated her back was injured from the crash but stated she did not need to go to the hospital at this time. I observed fresh damage and silver paint transfer on the rear end of Jaguar. There was blue paint transfer on the front end of the Honda. I met with the white male driver and identified him by his FL DL as Kirill Valerevich Plekhanov. Plekhanov was sitting in the driver seat of the Honda and there was nobody else inside the Honda. Plekhanov had the vehicle key in his left pocket which he removed and placed it on the front passenger seat. Plekhanov's head was slumped over and he appeared to be sleeping. When I spoke to Plekhanov, he opened his eyes slightly and started to use his cell phone. I informed Plekhanov I was on scene to conduct a DUI investigation and he stated he understood I was on scene to conduct a DUI investigation. During roadblocks Plekhanov became uncooperative and walked back to the Honda. Plekhanov opened the driver door and I had to prevent him from re-entering the Honda in fear he will drive away. I informed Plekhanov he was under arrest and to put his hands behind his back. Plekhanov turned up his nose and attempted to move his hands to his front. Myself and Officer Santos attempted to handcuff Plekhanov ordering him several times to put his hands behind his back. Officer Santos told Plekhanov he was going to be freed if he didn't comply and Plekhanov replied "I see me". After a brief struggle, Officer Santos and I were able to handcuff Plekhanov with two sets of handcuffs. During the struggle, Plekhanov pushed off his weight back toward officers and I held him down on the hood of the Honda. Plekhanov suffered an injury to his mouth after hitting the Honda's hood.

OBSERVATION OF DRIVER:

I smelled an odor of an unknown alcoholic beverage coming from Plekhanov. Plekhanov had difficulty keeping his head upright. Plekhanov had difficulty keeping his eyes open. Plekhanov's eyes were red and had a glassy appearance. Plekhanov's pupils did not change in size when presented with changes in light. Plekhanov speech was slurred while he was speaking. After Plekhanov exited the Honda, he was very unsteady on his feet and stumbling while walking. Plekhanov did not follow simple instructions such as to put his cell phone in his pocket. Plekhanov appeared very drowsy and continued to close his eyes while I was speaking to him. Plekhanov swayed while standing still.

DRIVER'S STATEMENTS:

Plekhanov stated he started driving from his place of employment in Boynton Beach, FL. Plekhanov stated he was on his way to his mother's residence in Lake Worth, FL when the crash occurred. When I asked Plekhanov if he knew what city he was in, he replied "Margate and that he lives in Margate". Plekhanov stated he knew he struck another vehicle but it not a hard impact. Plekhanov stated he drove away after striking the Jaguar because there was no damage. Plekhanov denied having any medical conditions that would affect his ability to operate a motor vehicle. Plekhanov denied taking any prescription medications or illegal drugs prior to driving. Plekhanov stated the Honda was registered to his mother but he drives the Honda regularly. I observed the airbag in the steering wheel deployed but the bag was stuffed back in the steering wheel. I asked Plekhanov if his airbag deployed during this crash and he replied "No, it happened when he struck a Publix truck on I-95".

Plekhanov had an odor of an unknown alcoholic beverage coming from his person.

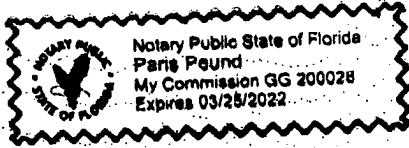

Plekhanov closed his eyes several times during the HGN/VGN roadside. Due to Plekhanov not following instructions, I stopped the HGN/VGN roadside before VGN could be completed.

WALK & TURN:

Plekhanov did not remain in the instructional phase position. Plekhanov was unable to maintain his balance during the instructional phase position and stumbled several times. Plekhanov started to walk before being instructed to begin. Plekhanov did not touch heel to toe and did not take 9 steps. Plekhanov stopped and restarted the roadside several times. Plekhanov began to stretch and slap himself on the side of face as if he was trying to make himself more alert. Before attempting the roadside another time, Plekhanov turned around and walked toward the Honda. I instructed Plekhanov to stop and he continued to walk to the Honda and open the driver door. I prevented Plekhanov from entering the Honda out of fear the public's safety and he was attempting to drive away. Plekhanov became uncooperative and was placed under arrest after a brief struggle.

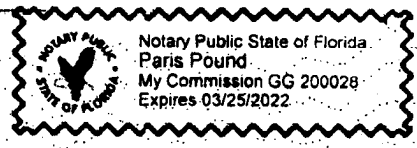

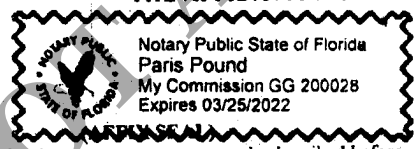

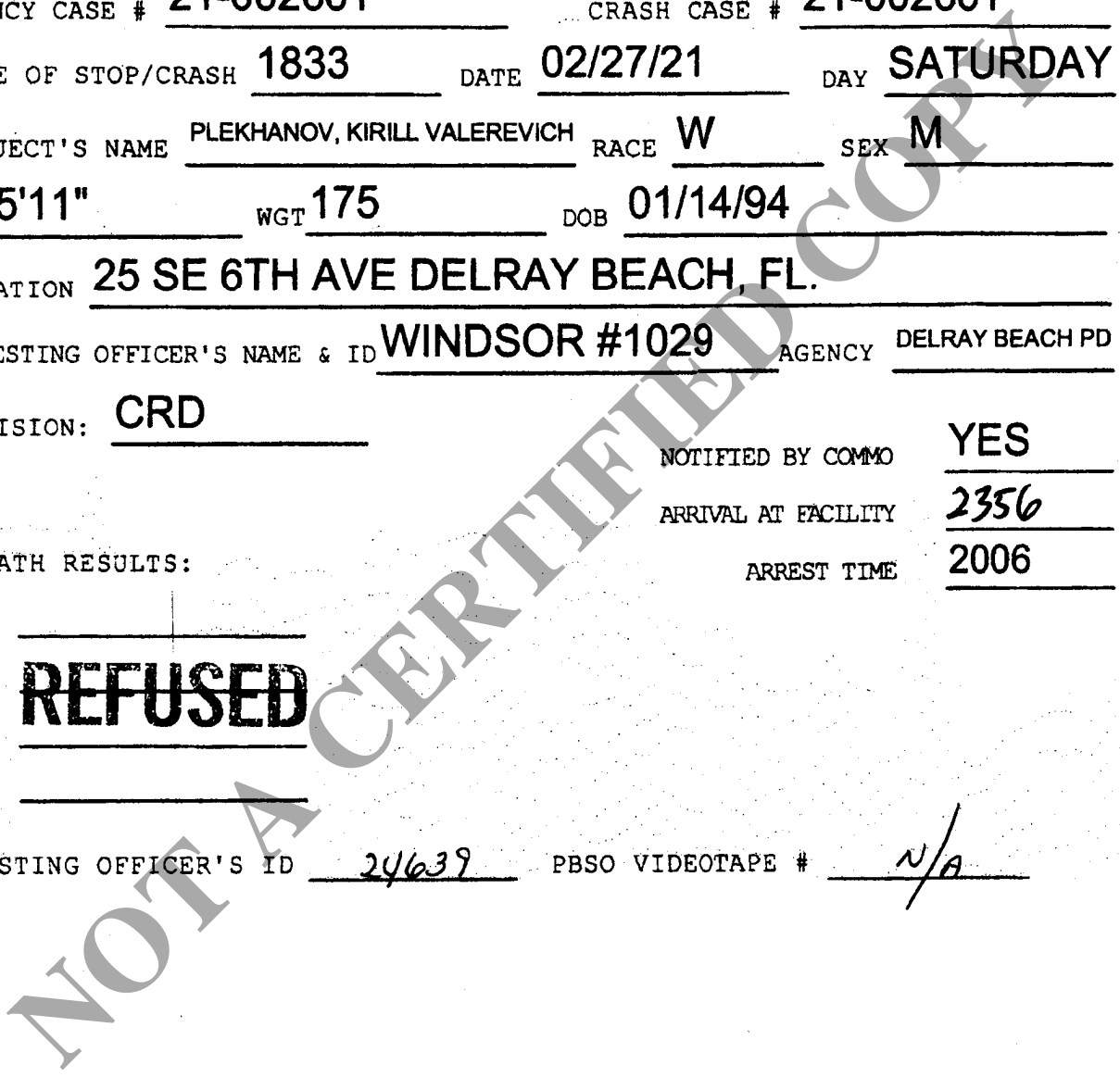
